The Applicant requests construction water service from Farmers Water Co. (FWC) for the construction project indicated above. It is FWC's sole discretion to grant or deny this application. Upon approval, FWC shall provide access to the water distribution system at the location approved by FWC and only authorized FWC personnel are permitted to connect the construction meter to the applicable blow-off or hydrant for service. Backflow prevention is required and must be approved by FWC prior to connection. The Applicant agrees to pay all water costs and meter and infrastructure repair or replacement cost if damaged or lost during the construction service. FWC charges a non-refundable establishment fee of \$35.00 on the first month's invoice. FWC may also require the Applicant to pay an advance sum equal to: (1) the estimated cost of installing and removing the facilities necessary for furnishing the construction service; (2) the first month's estimated bill for service; and/or (3) any applicable deposits as approved by the Arizona Corporation Commission. FWC will remove the meter one business day after the Service End Date. The Applicant is responsible for requesting in writing any extension beyond the Service End Date.

### WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I further agree to indemnify and hold harmless the Releases from any loss, liability, damage, or costs, including court costs and attorney's fees, that may incur due to my participation in such activity related to the construction water service, whether caused by negligence of the Releases, or otherwise.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement (Agreement) shall bind me, my partners, successors, assigns, legal representatives, officers, agents, and employees, and shall be deemed as a release, waiver, discharge, and covenant not to sue the Releases. I further agree that this Agreement shall be construed in accordance with the laws of the State of Arizona.

In signing this Agreement, I acknowledge and represent that I have read the forgoing, understand it, and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written Agreement, have been made, and I execute this Agreement for full, adequate, and complete consideration fully intending to be bound by the same.
